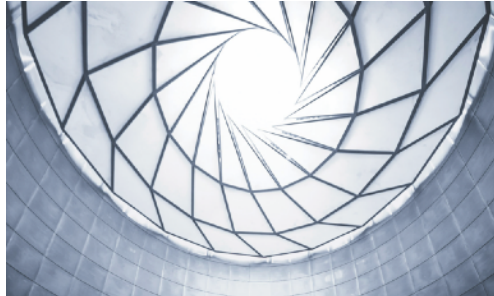


Human Rights Challenges and Opportunities in The Age of AI



Artificial Intelligence (AI) is rapidly becoming inseparable from our day-to-day lives – from deciding who is hired for a job or approved for a loan, to law enforcement’s use of face recognition, to the creation of AI-generated images and videos. As AI evolves and becomes more prominent, questions about how it is designed, used and governed are increasingly urgent for people’s rights and our democracy.

CDT is the leading organization working to protect people’s rights in the digital age. We work with policymakers in the U.S. and EU on effective guardrails and protections for AI, testifying before Congress five times in the past year and advising government agencies. Meanwhile, our [AI Governance Lab](#) is a leading public interest voice on

best practices for companies and governments. At a crucial time for this technology, CDT is leading conversations about how AI is tested, used, and governed – and helping developers, companies, and people impacted by AI systems to engage responsibly with the technology.

AI & Economic Justice

When someone is denied a job or a loan because of a flawed algorithm, or mistakenly accused of fraud and stripped of their government benefits, it can devastate their life. As companies and government agencies increasingly use AI in critical decisionmaking, CDT is a leading resource on appropriate guardrails, testing, and rules to protect people’s rights. CDT has published original work and policy recommendations about uses of AI in the [workplace](#), in public [benefits programs](#), in [housing](#), and in [schools](#). CDT is also a leading resource for state lawmakers considering AI legislation, and was recently named to the Commission created by [Colorado Senate Bill 205](#), the first law in the country that requires companies to assess high-risk AI tools for their potential to discriminate.

At CDT, we fight to advance civil rights and civil liberties in the digital age. In addition to our advocacy work, CDT’s research team produces deep-dive original scholarship to explore novel solutions to pressing issues in tech policy

Combatting Deepfakes

Just as AI tools introduce new opportunities for creativity, they have also made it easier than ever to produce and distribute harmful content at scale. In collaboration with the Cyber Civil Rights Initiative (CCRI) and National Network to End Domestic Violence (NNEDV), CDT leads a [Working Group](#) of leading tech companies, survivor advocates, and trust & safety experts to combat image-based sexual abuse, including deepfakes generated by AI. Our original research has uncovered the prevalence of [non consensual intimate images in schools](#), and helped educators and families better prepare. CDT is supporting the [DEFIANCE Act](#) – bipartisan, bicameral legislation to address NCII – and secured [commitments from leading tech companies](#) to better address this harm. Meanwhile, CDT’s [Elections & Democracy team](#) is working to address the impact of AI on elections, sharing [election integrity recommendations](#) for generative AI developers, investigating [how chatbots can mislead voters about their rights](#), and training state and local election officials to navigate this new age.

AI-Powered Surveillance

When law enforcement used face recognition to identify protestors at peaceful Black Lives Matter protests in Maryland and Florida, CDT spoke out – insisting that such unfettered surveillance violates people’s constitutional right to freedom of speech and assembly. CDT has raised the alarm about racial bias and the [disparate impact of face recognition](#), and advocates forcefully for a federal law to preserve people’s rights. We’re also deeply engaged on the use of AI for national
